- i) The Deputy Conservator of Forest (Monitoring & Evaluation) in the office of PCCF & HoFF shall assist the DFO (T) Jaintia Hills Division for carrying out operations in the Districts falling under jurisdiction of the DFO (T) Jaintia Hills Division, Jowai.
- ii) The Deputy Conservator of Forest (Forest Conservation Act) in the office of PCCF & HoFF shall assist the DFO (T) Khasi Hills Division for carrying out operation in the Districts falling under jurisdiction of the DFO (T) Khasi Hills Division, Shillong.
- iii) All the Divisional Forest Officers (Wildlife) and Divisional Forest Officers (Social Forestry) shall assist the Divisional Forest Officers (Territorial) in their respective Districts of jurisdiction.

Terms of reference of the District Level Special Task Force:-

- (1) Clamp down all illegally operating wood-based industries in the District, close them and seal the equipments used for conversion of timber.
- (2) Disconnect electricity supply to the unauthorised wood-based industries which have been closed at (1) above.
- (3) Prevent mushrooming of fresh unlicensed wood-based industries in the District.
- (4) Seize the illegal timber lying within the premises of illegally operating wood-based industries as per provisions of the Meghalaya Forest Regulation Act, 1973 and take further action in respect of such timber in accordance with law.
- (5) Prevent transportation of illegal timber to legally as well as illegally operating woodbased industries intended for conversion, and prevent movement of sawn timber from illegally operating wood-based industries to the destinations.
