TERMS AND CONDITIONS OF THE CONTRACT

I. Eligibility of Bidder/supplier

1. Suppliers should be registered/ authorized in India. Bidder should have tender specific authorization from the OEM/ Principal company and the original certificate should be submitted.
2. The supplier should have at least 5 (five) years' experience in the field of supply of computer hardware and peripherals.
3. The supplier should have OEM presence in India or channel partners / service providers, authorized distributors / dealers.
4. The supplier should have sufficient experience and proper infrastructure to provide requisite after sales service and support in the State of Meghalaya.
6. The supplying agency should be a profit making entity for the past 3 (three) years and its Annual Turnover during the last 3 years should not be less than Rs50.00 lakh. Details of the same need to be provided.
7. The bidder should submit documentary evidence in support of fulfilling eligibility criteria mentioned above along with the information i.e. Vendor details of the tender document.

II. Submission of Tenders

1. The bidder must obtain for himself at his own responsibility and at his own expense all the information which may be necessary for the purpose of submission of offer.
2. The suppliers may get themselves acquainted with the proposed work and study the specifications of the contract, site conditions, prevailing laws, regulations, other related issues, etc., carefully before tendering. The same shall be done at their own expense, responsibility and risk. No request for change of tendering conditions for want of information on any particular issue will be entertained by this office.
3. The rates quoted in the offer shall be for the complete item including supply, installation, testing, commissioning etc. The rate shall be firm and shall not be subject to exchange variations, labour conditions, fluctuation in railway/road freights or any other conditions whatsoever. The offerer must include in his rates sales tax, excise duty, octroi and any other tax and duty or other levy charged by central government or any state government or local authority, if applicable. No claim in respect of sales tax, excise duty, octroi or other tax, duty or levy whether existing or future shall be entertained by the tenderer. The rates shall also include transportation, loading, unloading, packing, carting, forwarding, freight charges, transit insurance cover and any other payment/taxes towards transporting the materials from other State/s.
4. The rates quoted should be all inclusive and include delivery, installation charges, warranty charges, all taxes, local levies, etc., and no further amount would be paid by Forest Department.
5. The offer should be made for systems of reputed manufacturers having all India service capabilities. The manufacturer's service network available across the country and especially in North East should be properly enumerated.
6. Prices quoted should be in respect of specified manufacturer with specifications as indicated in the DGS&D Rate List where applicable.

7. The supplier would be entitled to verify and satisfy themselves of the site conditions prevailing which would be done at their own cost, responsibility and risk.
8. The Proforma provided in **Annexure II (1) to II (4)** in case of technical bid should only be used strictly for submission of quotes. In case the agency desires to submit any additional information on the products / service, etc., the same may be furnished under head "Other Details" separately.
9. It may be noted that submission of the quote would imply explicit acceptance by the supplier of all the terms and conditions listed in the tender document.
10. A supplier may offer more than one model / make of product provided he is authorized to quote for the same.
11. The supplier will ensure that the tender reaches the specified office on or before the due date and time. Applications received after the due date and time or incomplete in any respect or not as per the Performa prescribed are liable to be rejected.
12. All disputes arising out of or in any way connected with this contract shall be deemed to have arisen in Meghalaya and only courts in Meghalaya would have jurisdiction to determine the same.
13. All the pages of the tender document should be signed together with seal of the authorized representative of the supplier.
14. Successful bidder should deliver the item and installation will be within one month from date of purchase.
15. Bidder should deposit cost of tender documents for each item separately mentioned in the table column **IV** and should also deposit earnest money @ 2% of the bidding amount through Demand Draft in favour of "Conservator of Forest (HQ)" payable at Shillong with tender documents. The EMD of the unsuccessful bidders shall be returned within a reasonable time or after expiry of the validity period. No interest shall be paid by Forest Department. Any offer without the EMD shall be summarily rejected.

EMD shall be forfeited in the following events:

- i. If the offer is withdrawn during the period of validity of the offer or any agreed extension.
- ii. If the offer is modified/altered without the knowledge of Forest Department.
- iii. If the tenderer backs-out.
- iv. If the tenderer attempts to procure the contract by furnishing false/incorrect documents and by giving false declarations.

17. Envelop No.1 (Technical Bid) should contain the following:

- i. Detailed technical aspects of the offer, including necessary brochures, etc. for the items to be supplied, as per the DGS&D Rate List (if available).
- ii. Copy of the valid authorized dealer/distributor certificate of the product proposed to be supplied. Copy of authorization certificate of the manufacturer.

- iii. Copy of the terms and conditions (Annexure I) duly signed and stamped for having accepted the same.
 - iv. Supporting documents required for conditions mentioned at paragraph no.I of Annexure I.
 - v. Vendor details duly filled in, signed and stamped along with necessary supporting documents.
 - vi. All the hardware and software shall have one year onsite comprehensive warranty covering all parts & labour from the date of acceptance of the systems by tendered. During the warranty period, the vendor will have to undertake comprehensive maintenance of the entire hardware, hardware components, software, equipment and accessories supplied by the vendor at the place of installation of the equipment.
 - vii. During the warranty period, the equipment should be repaired / replaced within three days of reporting of the defect. In case of vendor failing it, a standby arrangement should be provided till the equipment is repaired.
 - viii. The vendor shall be fully responsible for the manufacturer's warranty for all equipment, accessories, spare parts etc. against any defects arising from design, material, manufacturing, workmanship, or any act or omission of the manufacturer / vendor or any defect that may develop under normal use of supplied equipment during the warranty period.
 - ix. The vendor shall also be responsible to ensure adequate regular supply of spare parts for a minimum period of 5 years after the expiry of the warranty period whether under their annual maintenance and repairs rate contract or otherwise.
18. The Forest Department will make the full payment within 30 days from the date of installation and acceptance of the software/hardware.
19. Force Majeure should a part or whole of systems covered by this order be delayed in delivery due to reasons of Force Majeure which shall include lock-outs, strikes, riots, civil commotions, fire accidents, acts of God and war stoppage of deliveries by Government; refusal of non-receipt of import license for import items, the delivery period referred in their order shall be extended by a period(s) not in excess of duration of such force majeure. Each party undertakes to advise the other as soon as it becomes aware of the circumstances of such force majeure, so that actions under the provisions of this order can be mutually reviewed and agreed upon between the tenderer and Forest Department. If the force majeure condition extends over a period of two months both the parties of the order shall mutually discuss and arrive at an agreement for continuation or termination of the contract.
