**DETAILED NOTICE INVITING APPLICATIONS FOR ENGAGEMENT ON
CONTRACT BASIS**

The Principal Chief Conservator of Forests, Working Plan, Research & Training and District Council Affairs [hereinafter referred to as "PCCF (WP, R & T and DCA)"] invites applications for engagement on contract basis to the positions under the projects given below:

1. Engagement shall be purely on contract basis. The PCCF (WP, R & T and DCA) reserves the right to terminate the engagement at any time without any prior notice and without assigning any reason thereof.
2. A scanned copy of the application in a Format specified in **Annexure-I** in non-editable PDF format along with a copy of certificates in support of the educational qualification and work experience shall be emailed at pccfmeghcstrandt@gmail.com on or before **12.59 PM on 2nd January, 2025**. All such emails shall be sent under the subject **“Application for engagement on contract basis to the positions under various projects implemented by the Working Plan, Research & Training and District Council Affairs Wing”**.
3. A candidate may submit application for engagement to the positions under more than one project. A candidates can however be selected under only one project, for which he/she is found to be most suitable.
4. The selection of a candidate will be based on his/her performance in the interview to be conducted by an Interview Committee to be constituted by the PCCF (WP, R & T and DCA) in the order of merit as decided by the Interview Committee.
5. In case applications are received from a large number of candidates, the PCCF (WP, R & T and DCA) may shortlist the candidates for the interview on the basis of a written examination consisting of multiple choice questions. **The written examination will contain questions covering General Knowledge of the Meghalaya and India, General Science, Basic Mathematics, Forestry, Botany and Basic Computer Knowledge.** List of candidates who meet the essential qualifications specified in this Notice along with the date, time and venue of the written examination will be placed on website of the Forests and Environment Department,

Government on Meghalaya (<http://megforest.gov.in>). The same will also be communicated to all such candidates through email and mobile number given in the application.

6. The list of candidates shortlisted for the interview along with the schedule for the interview will be placed on website of the Forests and Environment Department, Government on Meghalaya (<http://megforest.gov.in>). The same will also be communicated to all the shortlisted candidates through email and mobile number specified in the application.
7. The candidates shortlisted for the interview shall, along with their original copy of the application submitted through email and the certificates in original in support of their educational qualification and work experience, report for the interview at the time, date and venue displayed on website of the Forest and Environment Department, Government of Meghalaya.
8. At the time of verification of original documents, if it is found that an attempt has been made by the applicant to wilfully conceal, misrepresent or canvass the facts, his/her candidature will not be considered.
9. Decision of the Interview Committee in all matters relating to the eligibility and work experience of a candidate will be final and binding on the candidates and no enquiry or correspondences will be entertained from any individual in this regard.
10. The PCCF (WP, R & T and DCA) and the Interview Committee shall reserve the right to reject candidature of any applicant in view of incomplete information provided by the candidate in the application or for any other reason.
11. The list of candidates selected for each position along with candidates kept in waiting list will be displayed on website of the Forests and Environment Department, Government of Meghalaya (<http://megforest.gov.in>). The successful candidate will be informed through email at the email ID given in their application to join the position. In case a candidate fails to join the position within 15 (fifteen) days from the date given in such communication, the position will be offered to the next candidate in the order of merit decided by the Interview Committee without making any further correspondence with such defaulting candidate.
12. Depending upon the availability of funds and actual work requirements or for any other reason, the PCCF (WP, R & T and DCA) reserves the right to increase or decrease the number of positions.
13. No Travelling Allowance (TA) or Daily Allowance (DA) or any other amount of whatsoever nature will be payable to the candidates for attending the interview.
