For and on behalf of the Meghalaya Zoo Project Implementation Society (MZPIS), the undersigned invites sealed Tenders in two (two) cover bids system *i.e.* a **Technical Bid** duly affixed with a non-refundable court fee stamp of Rs. 2,000 (Rupees Two Thousand) and a separate **Price Bid**, or construction of five (5) animal enclosures in the Meghalaya State Zoo in Ri-Bhoi district at an estimated cost of **Rs. 1,54, 33, 645/-** (**Rupees one crore fifty four lakh thirty three thousand six hundred forty five**) only from the firms and persons registered with the Meghalaya Public Works Department (Building) as Class-I contractor who meets each of the eligibility criteria specified in the detailed tender documents.

Willing tenderers may inspect the Detailed Tender Booklet containing the terms and conditions including the eligibility criteria for submission of the tenders, and detailed estimates and drawings of the works to be executed in office of the undersigned on all working days from 12th July 2021 to 6th August 2021during officer hours A copy of the Detailed Tender Document may be purchased from office of the undersigned on the above dates on payment of a non-refundable amount of Rs. 4,000 (Rupees four thousand) only either in cash or by a crossed Demand Draft or a crossed Pay Order or a Banker's Cheque from a bank having a branch in Shillong drawn in favour of the Meghalaya Zoo Project Implementation Society payable at Shillong.
- 3. Tenders complete in all respect shall reach office of the undersigned located in office of the Principal Chief Conservator of Forests, Sylvan House, Lower Lachumiere, Shillong 793001 **upto 1.00 PM** on **9**th **August 2021.** The Technical Bids will be opened on the same date at 1.30 PM in the presence of the tenderers or their authorised representatives who desires to remain present. Due to any unavoidable reason(s), if the office of the undersigned remains close on the last date prescribed for receipt of the tenders, the next working day shall be considered as the last date for receipt of tenders and opening of the Technical Bids.
- 4. Earnest Money Deposit: Each tender shall be accompanied with refundable Earnest Money Deposit amounting to Rs.3,08,680/- (Rupees Three lakh eight thousand six hundred eighty) only in the form of a crossed demand draft or a crossed Pay Order or a Banker's Cheque or a Fixed Deposit or a Call Deposit from a bank having a branch in Shillong drawn in favour of the Meghalaya Zoo Project Implementation Society payable at Shillong. If the tenderer is a member of Scheduled Tribe (ST) or Scheduled Caste (SC), he may submit EMD amounting to Rs. 1,54,340/- (Rupees One lakh fifty four thousand three hundred forty) only.
