**Notice Inviting Applications for Raising Plantations on Community and Privately Owned Land**

Social Forestry and Environment Wing in the Forests and Environment Department, Government of Meghalaya raises plantations on community and privately owned land under the Centrally Sponsored Schemes – “National Afforestation Programme (NAP)” and “Green India Mission (GIM)”. Such plantations are also raised from monies available in the Meghalaya State Compensatory Afforestation Fund (CAF), Meghalaya Environment Protection and Restoration Fund (MEPRF), Meghalaya Minor Mineral Reclamation Fund (MMRF) and various other State Sector Schemes. Entire cost of creation and maintenance of such plantations borne by the Department. Preference will be given to the land located in important catchments and the areas affected by mining.


